## ***Peninsula Saddle Club*** **Campground Rules**

1. During burn bans, NO fires are allowed.
2. No electrical hookups allowed. No water hookups allowed.
3. No off road vehicles (ATV's, dirt bikes, 3 wheelers, 4 wheelers, etc.)
4. Dogs should never be unattended. Keep all dogs on lead or tied to your vehicle at all times. Please clean up after your dog.
5. Do not bathe horses or any vehicles.
6. No turning horses out in the arena. It is to be used for riding purposes only.
7. No make-shift corralling allowed. No tie-out of horses allowed. Do not place horses in area behind grandstands.
8. Commercially designed portable fencing is OK. No loose horses.
9. Horses may NOT be boarded without the owners camping overnight on the property.
10. Pasture fence on North side in not PSC property. Do not connect portable fencing to it.
11. Keeps gates closed. Turn off water. Put out fires. Clean up after yourself. Please place trash in green container at the front gate.
12. You will be Liable for any damages caused by you and/or your animals. Any damages of PSC property will be billed for accordingly. Vandalism is a crime and will be prosecuted to the full extent of the law.
